

Guideline Range, which states:

" In General. In a case in which a defendant is serving a term of imprisonment, and the guideline range applicable to that defendant has subsequently been lowered as a result of an amendment to the guidelines manual listed in subsection (c), the court may reduce the defendant's term of imprisonment as provided by 18 U.S.C. 3582(c)(2) and as required by 18 U.S.C. 3582(c)(2) "

The defendant contends that the enactment of the aforementioned amendments affect his sentence and as such sentence should be reduced accordingly.

III. PRAYER

Wherefore as, premises considered, the defendant **PRAYS** that this Honorable Court **GRANT** his Motion for reduction of his federal sentence pursuant to Title 18 U.S.C. 3582(c)(2) and reduce his sentence accordance with the provisions of this Title and newly amended guideline range.

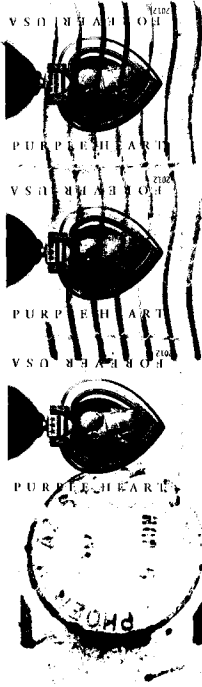
